

TERMS AND CONDITIONS

As a condition of the acceptance of this application, it is mutually agreed and understood that applicant and all persons for whom he/she is acting will be bound by the terms and conditions of this stall application as set forth below, and the applicant represents that he/she has been granted the appropriate authority by all owners of the horses in the care of the applicant, to make this application and to agree to its terms and conditions, and to bind such owner(s) to the same.

Eligibility and Stabling

1. Qualifications for Retama Park:

A horse that is more than 12 years of age may not start in a pari-mutuel race in this state unless:

- a. The horse has finished 1st, 2nd or 3rd in an officially sanctioned pari-mutuel race during the 12 month period preceding the race in which the horse is to start; or
- b. Upon due consideration of the horse's prior past performance, the board of stewards has given specific authorization for the horse to start.

2. Stalls will not be reserved for horses other than those on your approved list. If you obtain other horses at a later date, subsequent stall approval will be required by the Racing Secretary before shipping.

3. Upon the assignment of each dormitory room, the applicant agrees to a nonrefundable fee of \$100 for each room allotted.

4. Trainers making balanced stall applications will be given a preference.

5. Pony stalls will be allocated on an individual basis, with preference given to trainers with 12 or more stalls. If you wish a pony stall, it must be listed on your application.

6. Stable area:

a. No dogs shall be allowed in the stable area of Retama Park (except Service Dogs registered with Retama Park Security).

b. Wood shavings required for bedding at Retama Park.

c. Only Retama Park rental hot walkers are permitted.

d. All hoses located in the Retama Park stable area must have an automatic shut-off nozzle and shall be turned off when not in use. Water consumption will be monitored by Retama Park in the stable areas.

e. Only biodegradable soap may be used.

f. All manure and wood shavings must be placed in the containers designated by Retama Park for such purpose.

g. A \$10.00 fee will be assessed for each stall that is not stripped upon leaving.

h. A \$75.00 fee will be assessed for each dorm key not returned.

7. Release and indemnity agreement:

Applicant recognizes the risks of the activities to be conducted at the Racetrack by or on behalf of applicant, the owners of the horses named in this application and all other persons for whom applicant is acting (applicant and such owners and other persons are collectively referred to as "indemnifying parties"), and has determined that the facilities at the Racetrack are reasonably suited for all horse racing related activities to be conducted by or on behalf of any such parties. Retama Development Corporation (and its partners, officers, directors, agents, vendors, employees, contractors, visitors and licensees, collectively "Retama Park") shall not be liable to any of the indemnifying parties or any of their employees, agents, invitees or visitors, or to any other person whomsoever, for any injury or claims for injury to persons or damage to property on the Racetrack premises or any adjacent area caused by the negligence or misconduct of any of the indemnifying parties, their employees, agents, invitees, visitors or any other person entering the Racetrack premises under express or implied invitation of any of the indemnifying parties, or arising out of the use of the Racetrack premises and facilities by any of the indemnifying parties. The indemnifying parties hereby agree to release Retama Park from and to indemnify and hold Retama Park harmless from any liability, loss, expense or claims (including reasonable attorneys' fees) arising out of such injury or damage. The indemnifying parties shall not be liable to Retama Park or to any other person whomsoever entering the Racetrack premises under express or implied invitation of Retama Park, for any injury to persons, claims for injury or damage to property on the Racetrack premises or any adjacent area caused by the negligence or misconduct of Retama Park, and Retama Park agrees to release the indemnifying parties from and to indemnify and hold the indemnifying parties harmless from any liability, loss, expense or claims (including reasonable attorneys' fees) arising out of any such injury or damage. In the event of any inconsistency between these provisions and any mandatory provisions of the Texas Racing Act or Rules of Racing, the Texas Racing Act or Rules of Racing, as applicable, shall control. Further, these provisions shall be deemed to be amended to the extent of, and to be in compliance with, any mandatory provisions of any amendment to the Texas Racing Act or Rules of Racing. The foregoing release and indemnification provisions shall be construed in a manner consistent with the limitations set forth herein to be as broad and inclusive as permitted by the laws of the State of Texas.

- All horses must show proof of vaccination on the Health Certificate for EHV-1 in the past 6 months (180 days)
- Original** Health certificates issued within the last 30 days must accompany any horse (all breeds) shipping into Retama Park grounds.
